

95.4 per cent of injured workers in the Southern Downs returned to some form of employment (three year average). For Queensland overall, 94 per cent of injured workers returned to work.

Injured workers in the Southern Downs were off work for 36.1 days per claim on average, compared to the Queensland average of 45 days per claim.

Workers' compensation claims by workers in high risk industries

Manufacturing had the highest number of claims per year -70 claims on average over the three years 2014-15 to 2016-17. Agriculture, forestry and fishing had the second highest number of claims per year -53 claims on average over the three years.

The highest claim rates were recorded for workers in the manufacturing industry (62.3 claims per 1,000 workers), followed by wholesale trade (52.5 claims per 1,000 workers). The industries with the highest average statutory costs per claim were health care and social assistance (\$14,049) and transport, postal and warehousing (\$13,810).


