This document outlines the fees payable by workers' compensation insurers for [COVID-19 telehealth items announced by Medicare](#).

Given this WorkCover has extended the use of the COVID-19 telehealth and telephone items to all medical practitioners and/or patients who are unable to consult face to face during this pandemic.

Fees in this schedule are payable only to medical practitioners who meet the provider eligibility criteria outlined in the current MBS. Practitioners must ensure that their chosen telecommunications solution meets their clinical requirements and satisfies privacy laws.
